The SRS charge for **Year 7** is **\$250**. (This comprises of **\$405** less **\$155** Government Textbook and Resource Allowance).

The SRS charge for **Year 8 - 10** is **\$280**. (This comprises of **\$435** less **\$155** Government Textbook and Resource Allowance).

The SRS charge for **Year 11 and 12** is **\$300**. (This comprises of **\$637** less **\$337** Government Textbook and Resource Allowance).

The Government Textbook and Resource Allowance is paid directly to the school for eligible students. The Department of Education pays a Government Textbook and Resource Allowance (TRA) for Secondary Students to the school for students in Years 7 – 12. The Department encourages schools to provide Student Resource Schemes to minimize costs for parents. Please see the back of the Participation Agreement Form for eligibility.

- **QParents** - To register email qparents@clevelanddistrictshs.eq.edu.au to obtain a QParents Invitation and follow the emailed instructions. Once your QParents account is active, go to the payments tab. Select the invoice you wish to pay for, record the CRN and invoice number. Follow the prompts to complete your payment
- **BPoint**- Click on the link at the bottom of your invoice or statement, this will take you to the secure payment portal. For debit and credit card payments only. BPoint payment plans available. Contact the finance office to arrange.
- **Direct Credit Via Internet Banking**

Please ensure you include - Student Surname, Initial, Payment Reference – (eg SmithJ YR8SRS) in payment description.
- **Payment Window** - Visit the school office payment window to pay by Eftpos or Cheque. Open Tuesday and Thursday from 8.00am – 11.00am.
- **Phone Payments** - Call the automated 24hour payment line on 1300 631 073 and have your credit/ debit card details available, together with your CRN and invoice number which you will have received via email.
- **Centrepay Automatic Deductions** - Fortnightly deductions can be made from Family Tax Benefit, Pension or Newstart payments. Collect a form from the school office, complete the form and return it to the school office for processing. **Please note: the minimum Centrepay payment amount is \$30.00 per fortnight. The early payment discount does not apply if you choose this option.**
